General of Tax No. 47/PJ/2008 Article 1 Paragraph 7. This process is done online and in real time through the Service Provider of the Application. (mobile device). All Republic of Indonesia police officers, members of the Indonesian National Army, and governmental personnel are required by law to electronically file their yearly income taxes (PPh). Every employee of BUMN and BUMD, as well as every worker in other business and nonprofit sectors, is subject to mandates from the government. An annual PPh SPT can be filed electronically by visiting the DJP Online website at https://djponline.pajak.go.id or the website of the electronic SPT service provider. This process can be completed online and in real time.

A month after the end of the calendar year, the Government must provide evidence of Article 21 PPh cutbacks (Form 1721-A2), as per the Ministry of State Apparatus Declaration and Bureaucratic Reform of the Republic of Indonesia No. 8 Year 2015 No. 3 on Treasury. For instance, cut evidence for the 2015 Tax Year must be published by January 31, 2016, at the latest.
